2. IELI will send you an offer letter and invoice for the total amount payable.
3. This course is registered under CRICOS Provider 02916F. Students should check at www.immi.gov.au for the requirements for an Australia student visa for citizens of their country. We recommend that you assess yourself against these criteria before paying fees for your IELI course.
4. When you have read the required visa regulations, please complete the second page of the offer letter and sign it. **IMPORTANT:** Your signature on the offer letter means that you agree to all conditions of enrolment. Please pay the required fees to IELI before the invoice due date. (If you cannot meet this due date, please contact our office as soon as possible.) Please return a copy of the signed offer letter and send proof of payment to IELI before the due date.
5. IELI will complete your enrolment and send you a confirmation letter and Confirmation of Enrolment (if required). If you are applying for a student visa, you can then complete the visa application process.
